

# Transport Guidance for learners with Additional Learning Needs 2021 - 2022

## 1. General principles of eligibility

If you are under 19 on the 1<sup>st</sup> September 2021 and reside more than three miles from the College you may be entitled to a free bus pass to access ALN transport.

If you live less than three miles from College **or** you are over 19 on the 1<sup>st</sup> September you are not eligible for free transport so you may have to cover all or some of the costs.

### 2. Subsidised Transport Costs

For 2021 – 2022, <u>ALL</u> users of ALN transport who are over 19 and live less than three miles from the College, will be required to make a contribution towards the costs of transport. The balance of the transport costs will be subsidised by the College via a Financial Contingency Fund (FCF), as long as you complete a College FCF Form and meet the eligibility criteria.

Your contribution will depend on where you live and the number of days you study each week. Below is an illustration of contribution you will have to pay, with an option to pay termly, monthly or weekly.

#### 3. Financial Assistance towards Transport Costs

If you wish to access ALN Transport at the subsided rate (Section 2) then you will need to apply and be awarded the subsidy from the College's Financial Contingency Fund (FCF).

Please note that a FCF Award is means tested, and full or part Awards may be granted. Early application for Funding support is essential as there is a limited amount of funding available.

You may be eligible for Educational Maintenance Award (EMA) (if you are under 19) or the Welsh Government Learning Grant (WGLG) (if you are over 19) to cover some or all of these costs.
